PARK AND SWIM SCHEME

Terms and Conditions

1. The Park and Swim rebate scheme only applies to meters designated as Park and Swim meters. Each time you visit, you will need to pay your parking by your nominated credit card (i.e. the same card you have registered for the refund). The discount will be credited to this card each fortnight. (Please note: There will be a processing delay of about one week.) Only Mastercard and Visa are accepted.
2. To obtain your reimbursement, you must swipe your pool access card on entering the pool. Discounts cannot be processed without your pool access card. Concession visitors must present their Park and Swim card at reception.
3. The rebate will only be paid if you have used your nominated credit card at the Park and Swim parking meters and swiped your Pool Access Card at the turnstile or presented your Park and Swim Card at Reception.
4. The maximum parking fee claimable is two hours per day.
5. Parking discounts are only available to people using the North Sydney Olympic Pool and its facilities during the advertised operating hours.
6. Your entry to the North Sydney Olympic Pool must be within 15 minutes of the time marked on your parking meter ticket. Your refund will not apply if your pool access card entry log is after this time.
7. Parking Stubs are to be dropped into the container next to the turnstiles so that Council can reconcile the receipt transaction number. Concession visitors must hand their Parking Stub into Reception.
8. Only one person can claim the parking discount for each parking ticket.
9. In the event of a system breakdown, your stub must be presented to reception for processing.
10. It is the responsibility of registered users to advise Council of any changes to their credit card details or pool/Gym membership status. This includes card or name changes, new credit card expiry dates, etc. Without updated information it will be impossible for Council to process a refund until details have been supplied. If your details change, you will need to complete a change of credit card form, which is available from Pool Reception or Council's website.
11. The discount cannot be paid as cash over the counter.
12. Council will reconcile and reimburse registered users each fortnight. (There is a processing delay of about one week.)
13. Council is not liable for any parking fines incurred through illegal parking.
14. Council reserves the right to vary or cancel this scheme.
