EXECUTIVE SUMMARY:

During this period of 1 July -30 September 2020, 148 applications of all types were received, of those, all but two applications have already been determined as of 17 February 2021.

A total of 151 applications were determined in Q1 2020/21 with a mean processing time of 71 days.

BACKGROUND

This report provides a list of the applications received by Council between 1 July 2020 and 30 September 2020.

Its purpose is to provide Councillors and other interested persons with some understanding of the application types received and processed by the Development Services Department. During this ,148 applications of all types were received and of those, all but 2 applications have been determined as of 17 February 2021.

The two outstanding applications are both significant applications, with one being for the MLC site in North Sydney, which we have been waiting on a determination date before the Sydney North Planning Panel since late November 2020. The application for an apartment building located at 30 Grosvenor Street required substantive amendments and will be determined at the March 2021 meeting of the North Sydney Local Planning Panel.

A total of 151 applications were determined in Q1 of financial year 2020/21 at a mean of 71 days.

CONSULTATION REQUIREMENTS

Community engagement is not required.

DETAIL

From time to time, considerable interest is expressed by Councillors, applicants, property owners and the broader community regarding the receipt and processing of development applications.

The attached computer generated report summarises the applications received by Council in Q1 of the 2020/2021 financial year. Contained within the report is:

- The application number expressed as year, sequential number and modification number, if any; i.e. 2005/92/5 is modification 5 to an application originally received and determined in 2005;
- The date received by Council;

- The determination date if applicable;
- A brief description of the proposal;
- The property address;
- The applicant's name;
- The estimated cost for new works applications
- A brief description of the type of application.

Full details of each application are available through DA Tracking on Council's website.

A version of this report is also created monthly and these reports, in conjunction with an outstanding application by officer report, are used for application management and work allocation purposes by Team Leaders and Management within the Development Services Department.

Trend Analysis

It is important to have regard to the trends demonstrated by application lodgement.

Quarter 1 appears to remain impacted by the COVID-19 crisis as was noted in the lodgement figures for Q4 of the last financial year 2019/20. This is reflected in the total number of applications received being some 12% below the mathematical average of the preceding five years as well as around 14% below that of the number of applications lodged for Q1 of the last financial year; 2019/20.

The application lodgement rate remains notably below average though significantly recovered from early indications of around a 30% drop off in application number observed during the month of March 2020.
