EXECUTIVE SUMMARY:

This report presents information and a preliminary concept design for an additional dual Cricket practice net in Primrose Park.

FINANCIAL IMPLICATIONS:

There is no current funding allocation for the construction of additional Cricket practice nets within North Sydney. The estimated cost of construction of the proposed Primrose Park two additional practice nets is \$145,000.

BACKGROUND

As Part of North Sydney Council's Recreational Needs Study one of the key strategies and actions is to:

Progressively upgrade the quality and carrying capacity of sports facilities and supporting infrastructure to meet current standards.

Through the Sport & Recreation Reference Group meeting discussions and the Recreational Needs Study, cricket practice nets have been identified as a facility that are currently very limited in number, Council currently has only five practice permanent cricket nets across the local government area that are in high demand.

A report was presented to the Sport and Recreation Reference Group meeting held on the 20th May 2019 that presented the possible location of a dual lane Cricket Net facility at Forsyth Park. At this meeting it was resolved to recommend:

1. THAT the report in relation to the Forsyth Park Proposal to Construct Practice Cricket Nets be received

At the Sport and Recreation Reference Group meeting held on the 27th April 2020 Cameron Herbert requested an update in relation to the proposal to construct practice cricket nets at Forsyth Park

The Director Open Space & Environmental Services advised that the proposal would be unlikely to proceed due to potential noise impacts on the residential properties in close vicinity to the proposed site. At this meeting it was resolved to recommend:

1. THAT Council investigate locations for additional practice cricket nets and provide a further report to the Sport and Recreation Reference Group.

At the Sport and Recreation Reference Group meeting held on the 10th of November 2020 a report was presented to the group outlining information on potential areas for additional Cricket Practice Nets across the LGA. This report is added as an attachment to this report

At this meeting it was resolved to recommend:

- **1. THAT** the report be received.
- **2. THAT** the reference group determine Primrose Park as the viable priority for a proposal to construct additional permanent cricket practice nets.

3. THAT the cost of construction of the cricket nets be considered by Council in future Council budget considerations.

SUSTAINABILITY STATEMENT


The sustainability implications are of a minor nature and did not warrant a detailed assessment.

DETAIL

The only option to add a further practice net at Primrose Park is to run a dual net facility behind the existing nets.

There is enough room on site to do this without disrupting access and egress. There is an Ausgrid Street light that would need to be relocated as well as a small tree that may need to be removed.

The blue rectangle in the aerial picture below indicates this location.

BACKGROUND

As part of North Sydney Council's Recreational Needs Study one of the key strategies and actions is to:

• Progressively upgrade the quality and carrying capacity of sports facilities and supporting infrastructure to meet current standards.

Through the Sport & Recreation Reference Group meeting discussions and the Recreational Needs Study, cricket practice nets have been identified as a facility that is currently very limited in number and in high demand within the North Sydney Local Government Area.

At the Sport and Recreation Reference Group meeting held on 27 April 2020, Cameron Herbert requested an update in relation to the proposal to construct practice cricket nets at Forsyth Park

The Director Open Space & Environmental Services advised that the proposal would be unlikely to proceed due to noise concerns in the community surrounding the park. At this meeting it was resolved to recommend:

1. THAT Council investigate locations for additional practice cricket nets and provide a further report to the Sport and Recreation Reference Group.

CONSULTATION REQUIREMENTS

Community engagement will be undertaken in accordance with Council's Community Engagement Protocol.

DETAIL

North Sydney Council has several Cricket Practice Net facilities across the LGA both of Synthetic and Turf types. Below is an inventory of those facilities:



With limited Open Space around the existing Sportsfields there are limited opportunities that would allow a dual Cricket Practice Net facility to be installed.

Potential Sites

Primrose Park

Primrose Park has a dual facility already that was upgraded in 2018 from a single net to the current double. The only option to add further facilities here would be to run a new double net facility behind the existing 2 nets. There is enough room on-site to do this without disrupting access and egress. There is an Ausgrid street light that would need to be relocated as well as a small tree that may need to be removed. The picture below indicates its potential location.



Tunks Park

Options have previously been explored at Tunks Park through both the Sport and Recreation Reference Group and the Tunks Park Masterplan process. Whilst there are favourable positions at Tunks Park, the idea was not popular with the local community. Consequently there was no provision within the Masterplan for a Cricket Practice facility to be installed.

Anderson Park

Anderson Park currently houses one single Practice Net. Anderson Park formerly provided two cricket nets but this was reduced to one when the new amenities block was built in 2015. In addition, the building works resulted in the existing net being located partially behind the new building in a shaded corridor.

The community consultation process identified that the positioning of the current net is not ideal with the batting area being dark and isolated behind the amenities building. Also, consultation identified that there was Cricket Club and some community interest in a second cricket net being available on the basis that it was used informally by children and families and this was seen as a positive activity in the park.

There is no allocation for additional Cricket Practice Nets to be installed at Anderson Park within the current Plan of Management for the site. Action 7.3 in the Plan of Management states "Anderson Park Sportsground is not a "cricket only" facility. This POM does not recommend an additional cricket net within Anderson Park. However, the existing cricket net is recommended to be upgraded to be less isolated behind the building and with an improved approach."

The only option to add further facilities here would be to run a new double net facility along the southern side of the ground as indicated below:





Forsyth Park

As per the attached report there is room on the Western side of Forsyth Park #2 for a dual Cricket Practice Net facility.

Waverton Bowling Club

Dependent on the outcome of Council being able to acquire the site for future recreational purposes, there is the potential to have a multi-lane Cricket Practice Net facility within this site. Repurposing one of the existing bowling greens could see a multi-sport facility that could house Cricket Nets in summer, Netball, Basketball, Futsal, Tennis and possibly even Hockey facilities during the Winter season.

BACKGROUND

Through the Sport & Recreation Reference Group meeting discussions and the Recreational Needs Study, cricket practice nets have been identified as a facility that are currently very limited in number and in high demand within the North Sydney Local Government area.

DETAIL

There is a potential opportunity at Forsyth Park to install a dual lane facility similar to that of the new one installed at Primrose Park. The current location of the Long Jump pit at Forsyth Park is of suitable size in area to accommodate this type of facility. Diagram 1 and the photos below show the current location of the Long Jump pit.



If there are concerns regarding the removal of the pit it is possible to relocate it to run in an East-West direction at the Southern end of Oval #2. This is indicated in diagram 2 below:



Potential Cricket Wicket location

Potential relocation of Long Jump Pit

Construction – Cricket Nets

- Excavate to desired levels and dispose of Spoil (including Long Jump Pit);
- Install new concrete slab 30m long x 7m wide;
- Supply and install synthetic grass to top of slab; and
- Supply and install fully enclosed Cricket Netting system.

Estimated Cost - \$200,000 + GST

Construction – Long Jump Pit

- Excavate to desired levels and dispose of Spoil;
- Install 2 x new concrete run ups with synthetic grass;
- Supply and install treated pine sleeper pit; and
- Supply and install sand.

Estimated Cost - \$25,000 + GST

It is anticipated that a proposal to construct cricket practice wickets would reduce the current unmet community demand for this type of facility. However, a comprehensive community consultation process would need to be undertaken with adjoining neighbours as it is anticipated there would be some concerns regarding potential noise, traffic, parking and aesthetic impacts.
