Review of DA Consent Condition

Fee to cover cost of the review, consideration and determination of a matter is required by a condition of a DA or a Review of a DA to be to the satisfaction of Council's consent condition and only in relation to conditions ancillary to the primary development (typically roadway or footpath construction and works in kind, Sec 4.17 (2) of the Act) at the request of the owner, developer or Consent Authority. Subject to Council discretion and on condition that it is to be satisfied prior to issue of the Construction Certificate.
