BACKGROUND

On 13 July 2016, Council considered Notice of Motion 28/16 in relation to undergrounding overhead cables. Council subsequently resolved:

THAT Council call for a report on Council's master plan for undergrounding overhead power and other lines only within Council's mixed use and commercial areas with a view to its adoption in Council's DCP controls.

On 20 March 2017, Council considered a report prepared in response to this resolution. In particular, the report:

- examined Council's current policy position for undergrounding;
- provided a brief historical overview of previous undergrounding-related Council reports and motions;
- identified and discussed the benefits, issues and barriers to undergrounding; and
- compared Council's controls and funding mechanisms linked to undergrounding within the scope of relevant legislative obligations.


As the result of the report, a draft amendment to the North Sydney Development Control Plan 2013 (NSDCP 2013) was prepared.

As a result of the preliminary investigations, a draft amendment to NSDCP 2013 was prepared to facilitate better outcomes concerning the undergrounding of overhead cables, which include power cables and other utilities, within specific areas within the North Sydney Local Government Area. These areas are identified in the Undergrounding Master Plan. In particular, it is proposed to achieve this purpose by amending Sections 2.4.10 and 2.7.1 to Part B of NSDCP 2013 to:

- include references to Council's Undergrounding Master Plan;
- introduce ancillary amendments to support the Undergrounding Master Plan; and
- make provision for undergrounding of overhead infrastructure in association with significant new development within areas identified in the Undergrounding Master Plan.

Council resolved to endorse the draft Undergrounding Master Plan (Figure 1), and place a draft amendment to NSDCP 2013 on public exhibition.



CONSULTATION REQUIREMENTS

Community engagement has been undertaken in accordance with Council's Community Engagement Protocol.

SUSTAINABILITY STATEMENT

The sustainability implications were considered and reported on during the initiation phase of this project.

DETAIL

1. Public Exhibition

The draft Master Plan and draft DCP amendment were initially placed on public exhibition for 21 days from Thursday 18 May 2017 to Wednesday 7 June 2017. However, due to an administrative issue, it was noted that the exhibition period did not meet the minimum statutory requirement for exhibiting a draft DCP amendment (i.e. a minimum of 28 days is required). Therefore, the draft Master Plan and draft DCP amendment were re-exhibited from Thursday 22 June 2017 until Wednesday 19 July 2017 comprising a total of 28 days.

Notification letters of the exhibition period were sent to the North Sydney Chamber of Commerce, the Property Council of Australia, Telstra, Ausgrid, Lane Cove, Willoughby and Mosman Councils.

2. Submissions Received

Council received four (4) submissions to the draft Master Plan and draft DCP. Of these submissions, three (3) are from the general public and one (1) from a public authority. A summary and response to all submissions made is provided in Attachment 1. A complete copy of all submissions has been made available to Councillors via the submissions folder placed in the Councillor room.

3. Issues

Whilst three (3) of the submissions expressed general support for the proposal of undergrounding of overhead cables, four (4) submissions raised the following concerns:

- requests to include the entire length of Lavender Street as part of the Priority 2 Area on the Undergrounding Master Plan Map;
- tree protection during the physical process of digging;
- survey accuracy and cadastral information; and
- application to residential area where neighbours are willing to contribute to undergrounding in their area to achieve "economy of scale".


Each of these issues are considered in the following subsections.

3.1 Inclusion of Lavender Street in the Undergrounding Master Plan

Two submissions requested the amendment of the Master Plan to include the entirety of Lavender Street from Harbourview Crescent to Blues Point Road, as well as one property block of Arthur Street off Lavender (refer to Figure 2).

Under North Sydney Local Environmental Plan 2013 (NSLEP 2013) the subject area is predominantly zoned residential. However, a very small portion of Lavender Street is zoned B1 Neighbourhood Centre. This part of Lavender Street was originally excluded from the Master Plan as the focus is on street zoned commercial and mixed use.



Comment:

That part of Lavender Street to be included in the Master Plan is located within the Lavender Bay Heritage Conservation Area under NSLEP 2013, with a significant heritage listed retaining wall being located on the southern side of the street. These constraints may have originally resulted in the street's exclusion. However, these issues may be overcome through sensitive consideration.

However, it is also of note that:

- Lavender Street is a primary traffic route through the Lavender Bay Precinct, for traffic and pedestrian movement between the village centre in McMahon Point and mixed use area at the northern end of Milson Point;
- Given its proximity to Watt Park, Clark Park and foreshore open space, the inclusion of
 entire Lavender Street as Priority Area would improve public amenity associated with
 reducing the visual impact of network infrastructure; and
- The removal of utility poles on Lavender Street would eliminate obstacles to pedestrian flow and improve driver sight lines.
- Given that the inclusion of these priority areas for the undergrounding of power lines occur in the DCP, the impetus for the actually occurring, will be through re-development of land. It is noted that there is very limited re-development potential in this part of North Sydney.

The issue was also referred to Council's Engineering & Property Services (EPS) division for comment being the responsible section for infrastructure in road reserves. As a result, they raised no objection to the extension of the Priority Area to include the entirety of Lavender Street.

Recommendation:

That the draft Undergrounding Master Plan be amended to include the entirety of Lavender Street within the Priority 2 Area. This amendment is reflected in Attachment 2 to this report.

3.2 Tree Protection

One submission raised concerns that existing trees may be affected when undergrounding cables. The submitter could not find any relevant protection under Council's draft DCP Amendment.

Comments:

Section 16 to Part B of NSDCP 2013 relates to tree and vegetation management. This section requires consideration to be given to a development's impact on trees and vegetation.

The general objectives (s.16.1.1) to the Section specifically state:

O6 Protect existing trees and vegetation during construction of development.

Furthermore, Section 16.4 to Part B specifically relates to the protection of trees and vegetation during construction. The objectives (s.16.4.1) to this Section state:

O1 To ensure that all trees in the public domain and on private property (both the site of development and neighbouring properties) are adequately protected during construction of developments.

In addition, development is required to comply with Australia Standard AS4970 – Protection of trees on development sites. This requirement is typically applied as part of conditions to a development consent or other approvals and ensures best practice is pursued when the physical undergrounding work commences.

Recommendation:

That no further amendment is required to NSDCP 2013 as it already contains sufficient protection.

3.3 Survey Accuracy and Cadastral Information

A submission was received from Roads and Maritime Services (RMS) raising an issue with regard to excavation safety and survey accuracy during undergrounding of utilities. It was suggested that Council implements a requirement to undertake a survey in accordance with the Australian Standard AS-5488- Classification of Subsurface Utility Information, which classifies subsurface utility location and attributes information in terms of specified quality levels. Further to this, RMS indicated its willingness to provide advice to council with regard

to minimise potential destruction on cadastral and survey control infrastructure when undergrounding roadworks occur.

Comment:

This issue was referred to Council's Development Services for comment. It responded that

The cost of underground survey work is significant and should not be imposed prior to the lodgement of a development application. Typically, these types of surveys lead to the temporary marking of paving and other infrastructure identifying the type, depth and location of pipes. Cameras, ground radar and other scanning techniques are used. Very often pipes and other conduits are not where they are supposed to be, including Council maintained infrastructure. This is very common problem in older areas such as North Sydney where even "dial before you dig" information can occasionally be unreliable due to the age of the service installation and inaccurate records. Abundant caution during excavation as well as prior proper research is therefore required.

The requirement to carry out below ground survey can be incorporated into the relevant consent conditions. Detail design can then occur post consent but prior to the issue of a Construction Certificate. Council is not aware of any instances so far where other below ground infrastructure has prevented the undergrounding of the electricity mains.

Recommendation:

That Council includes a requirement for underground surveying work in its standard conditions of consent, where the undergrounding of overhead cables is proposed/ required. This would enable a high level of accuracy of undergrounding services, protect cadastral infrastructure and help to facilitate future development activities with minimal impacts.

3.4 Local Land Owners' Willingness to Contribute

A land owner from Lavender Bay expressed their and their neighbours' interest to contribute to the undergrounding of overhead cables in their area where it was located outside of the Priority Area. They believed that the large scale undergrounding project may enable economies of scale.

Comment:

A mixed funding approach by residents and both local and state governments might be feasible but it is wholly dependent on the agreement of all affected property owners. The suggestion for additional funding options is beyond the scope of the current DCP amendment. However, should Council be of a mind to do so, it could gauge residents' willingness to pay for undergrounding and undertake further investigations as a separate piece of work.

Recommendation:

That Council note the willingness to contribute to undergrounding overhead cable infrastructure.

4. CONCLUSION

The draft DCP amendment as publically exhibited sought to implement the Draft Undergrounding Master Plan, and amend the DCP in order to facilitate better outcomes

concerning the undergrounding of overhead cables within specific areas within the North Sydney Local Government Area.

A total of four (4) submissions were received by Council. As a result of the submissions, it is recommended that:

- Priority Area 2 of the Master Plan Map be amended to include the entirety of Lavender Street; and
- Standard Condition of consent be adopted to address the surveying of underground infrastructure.

Having completed the public exhibition of the Draft DCP amendment, it is recommended that Council adopt the attached draft DCP amendment and notify its endorsement in accordance with the EP&A Act.



SECTION 2 COMMERCIAL & MIXED USE DEVELOPMENT

2.1 Introduction

The North Sydney LGA contains a variety commercial centres ranging from one of Australia's largest commercial centres down to small scale neighbourhood centres focusing on one or a small cluster of retail shops and services.

The most significant commercial centre in the North Sydney LGA is the North Sydney Central Business District (CBD), which primarily comprises tall commercial towers with some isolated mixed commercial and residential development. Its close proximity to Sydney Harbour and City of Sydney provides the area with a vibrant and successful commercial centre. The CBD is well serviced by public transport and provides access to a wide range of employment, cultural, social, educational and recreational opportunities. Conversely, the amenity of the CBD is compromised by a general lack of open space, access to solar access and intensively used public walkways. Its good access to public transport and proximity to the Sydney CBD, reinforces the need to encourage high grade commercial floor space to ensure that the CBD continues to contribute to its status as a "global city" as identified under the Metropolitan Strategy.

The remaining centres of North Sydney comprise a variety of mixed use areas zoned either B1 – $Neighbourhood\ Business$, B4 – $Mixed\ Use$ or IN2 - $Light\ Industrial$. These centres generally provide for a wide range of residential, commercial and high tech industrial floorspace. The proximity of residential and commercial development can create potential conflicts which must be addressed at the design stage such that amenity of residents is maximised while also enabling commercial premises to operate effectively and contribute to a vibrant centre.

2.1.1 General Objectives

The general objectives of this Section of the DCP are to ensure that commercial and mixed use developments:

- O1 can meet the aims and residential and employment population targets as outlined in the State Government's *Metropolitan Strategy* and *Inner North Subregional Strategy*,
- O2 can meet the aims and dwelling targets of Council's Residential Development Strategy,
- O3 is consistent with the principles contained within the *Integrated Land Use and Transport Policy*;
- O4 provide various grades and sizes of commercial floorspace to accommodate a mix of business, service, high tech industry, retail and recreational uses,
- os are designed to contribute positively to their surroundings and particularly to diversity, vitality, social engagement and 'a sense of place',
- O6 provide active street frontages both during the day and night,
- O7 contribute to maximising public transport usage, walking and cycling,
- O8 provide an acceptable level of amenity to residents living within and adjoining centres,
- O9 are designed to mitigate against the extreme impacts of the sun, wind and rain,
- O10 provide adequate natural light to buildings, public places and streets,
- O11 incorporate innovative sustainable design to reduce energy and water consumption and meets or exceeds sustainability requirements,
- 012 minimise the acoustic impacts on residents from non-residential activities,
- O13 maximise opportunities for the sharing of views,

- P4 Pedestrian links must be lined with active uses along at least one side of the link to engage pedestrians.
- P5 Pedestrian links must be a minimum of 6m in width that is free from obstructions.
- P6 Escalators must be provided within the link where there is a substantial change in level.
- P7 The number of pedestrian entries to the link is maximised.
- P8 The extent of natural light to the link should be maximised where possible.
- P9 Signage must be provided at the entry to the linkage, indicating public accessibility and the street to which the connection links.
- P10 Opportunities for integration of public art installations within the link are to be maximised.
- P11 The linkage is to be designed to positively respond to the "safer by design" principles.

2.4.10 Streetscape

Objectives

- O1 To ensure that footpaths, kerb and guttering and street trees contribute to a consistent streetscape.
- O2 To promote the creation of lively and active street and laneway frontages.
- O3 To create visual interest in the built form.
- O4 To create a feeling of safety both by day and night.

0405 To minimise visual clutter associated with overhead infrastructure.

Provisions

- P1 The ground level of buildings should align with the corresponding level of the adjacent footpath, laneway or outdoor space.
- P2 Continuous active uses, such as shops and cafes, should be provided at the ground level of the building to all streets, laneways and public spaces.
- P3 Where practical, the building's ground level façade to a laneway should be provided as an active frontage (e.g. has a retail or commercial premises fronting the laneway).
- P4 Landscaping and changes in level at building frontages is to be avoided where possible to facilitate natural surveillance of public areas and views into buildings.
- P5 All ground level windows fronting street, laneways and public spaces must be glazed with clear glass, to promote active surveillance of the public domain.
- P6 All ground level shopfronts are to have a zero metre setback unless specified in the relevant area character statement (refer to Part C of the DCP).
- P7 Introduce visually interesting elements to the building façade such as articulation, detailing and art works.
- Streetscape elements, such as street furniture, lighting, paving, awnings, outdoor seating and umbrellas, are to be consistent with Council's Public Domain Style Manual and Design Codes.
- P8P9 Undergrounding of overhead infrastructure should be provided in association with significant new development, consistent with the North Sydney Council Undergrounding Master Plan.

2.4.11 Entrances and exits

Objectives

O1 To enable equitable access to all persons regardless of ability.

Design of the public domain is important - too often buildings relate poorly to the public domain and public spaces are just the left over spaces between buildings. A well designed public domain is one which is accessible to all, encourages a diverse range of activities and users throughout an extended period of the day, and is safe and comfortable for all users. Successful streets and public spaces are the ones we enjoy walking along, shopping at or sitting in.

All Public Domain design should be in accordance with the *North Sydney Centre Domain Strategy*, the *St Leonards Public Domain Strategy* and *North Sydney Council Infrastructure Manual*.

2.7.1 Street furniture, landscaping works, utilities and equipment

Objectives

O1 To ensure that street furniture, landscaping works, utilities and equipment positively contribute to the community's enjoyment of the public domain, but does not impede pedestrian movement and safety or reduce visual quality.

Provisions

- P1 Where relevant, all works should be designed in accordance with:
 - (a) North Sydney Centre Public Domain Strategy;
 - (b) St Leonards Public Domain Strategy; and
 - (c) North Sydney Council Infrastructure Manual.
- P2 Where present, overhead wires are to be relocated underground along property boundaries, consistent with the North Sydney Council Undergrounding Master Plan.
- P3 Seating should be provided in public spaces that are not allocated to a specific use (e.g. a café) for people to 'hang out', take refuge and rest.
- P4 Seating or seating areas should be positioned at the edge of footpaths where through movement is not obstructed.
- P5 Pedestrian sight lines should not be obstructed by landscaping or other street improvements.
- P6 Public areas should be free from clutter and unclear level changes, having particular regard for accessibility.
- P7 Publically accessible areas are to be provided with a high quality of lighting for security and amenity purposes.

2.7.2 Public entertainment and expression

Objectives

O1 To ensure that venues for public entertainment and expression of community identity are provided.

Provisions

- P1 Formal and informal spaces for public entertainment should be provided.
- P2 Multi-functional street furniture should be incorporated into the design (e.g. a flat bench may become an informal plinth for performance artists).
- P3 At least one space within the North Sydney Centre must be provided that is large enough to hold an open air performance or market.
- P4 Public notice boards and kiosks should be provided in locations where people will be gathering.
