The Mayor said she would investigate and get back to the Precinct on this matter.	Council Manager Parking Stations & Business Operations has advised that the Mater Hospital is currently undergoing a 2-year project to establish a Palliative Care service and extend their day surgery capacity. These works required the demolishment and rebuilding of their existing staff parking facilities. Mater Hospital initially requested on-street parking permits for their staff to park however this was not a viable solution as demand for parking is already very high in the Wollstonecraft area. In turn following a request for car park spaces, analysis of several years of data (including data pre-COVID) found that Nicholson St car park (closest to the hospital) is underutilized. 40 vehicles can fit in the basement permanent parking hence the overflow of 20 reserved spaces placed in the public area on 14 April 2023. The arrangement with the Mater Hospital is temporary and will cease once their renovations are complete. The aim is to reduce their parking spaces as their works progress and their onsite spaces gradually start opening back up. A large proportion of the items on sale can be categorized as luxury and so the first to be scaled back on. In our current selection of stallholders, we have ensured that there are a number of lower-priced items. The Christmas Markets do tend to be the largest of the year and a good point to compare this December to last year, however, in 2023 we are also affected by unavoidable train works this year due to the Metro so that will most likely lessen crowds. To address the question re stallholders, for the past 5 years, we have maintained a rough demographic of 50% regular stalls (exhibiting a max of 3x per year), 25% occasional stallholders, and 25% new stalls. The café not being open has definitely affected overall daily footfall to the site and could be having a knock-on effect on events but this is difficult to measure. I have been informed that Council is currently working on getting a new tenant in as fast as possible.	Close for Council

2		Sydney Heritage Fleet (Shf) - AE and GI were invited to address the meeting on a proposed re-use of Woodley's Shed and Office building to create a new business in Berry's Bay. SHF first addressed the Waverton Precinct group in 2020, so the proposal to move a segment of the operation of SHF to Berry's Bay dates from then. The proposal involves the conversion of Woodley's Shed to house small historically significant craft, have a place to put them on display, a woodworking workshop for historical boat restoration and invite people to work on small craft Council's recent Waverton Peninsula Working Group was looking into the condition of Woodleys Shed condition. However, a dilapidation report has not been shown. We do not know the overall condition of this structure. It was agreed that: • for discussions to move forward, the community will need time to review the proposal in more detail. • more detailed material will be circulated with the March meeting Minutes, which will facilitate further discussion. This will be a future Agenda item, around other presentations by WHT representation that may occur in April and an address by Council's General Manager in May. February		Berry's Bay 'Masterplan'/WHT project - Project representatives will be attending our March meeting. Poisonous sediment in the shallow harbour waters around the slipway of the former Woodley's site (and in other parts of Berry's Bay) remain a significant concern as they are not acknowledged in the Masterplanning process, so far. At the invitation of the Chair, BR addressed the meeting at this point. In his role as an Environmental Engineer, he has extensive understanding of this situation and he has made submissions and provided data to all relevant parties, plus acted as an expert witness to the recent Upper House Inquiry. However, Maritime has not made any progress on remediating this area - plus both the EPA and TfNSW remain silent on this aspect. BR said he regarded this as one of the most polluted water ways in Sydney Harbour and it must be cleaned up as soon as practicable and certainly before anyone starts walking, playing, swimming, kayaking etc in the area. The remedial idea of dumping new sand on top of the polluted chemicals, as floated by TfNSW, he regarded as "simply preposterous".
