Summary of Actions Arising (SOA) 2023 Milson Precinct

Council's Manager Community Development noted the Precinct Committee's feedback and has advised that the Protocol for Homeless People in Public Places assists and guides government, non-government organisations, and private businesses as to how to interact and engage with people experiencing homelessness, so they are treated respectfully, with dignity, and do not face discrimination. The Mental Health Act and Police powers underpin Council's authority and ability to act in this area. It is important for the Precinct Committee to be aware of the limits of Council's powers as described above. Brush Turkeys are a protected native animal under the NSW Biodiversity Conservation Act and consequently, Council does not have authority to relocate or cull Brush Turkeys in order to reduce this localised population. Residents suffering particular health-related or property damage issues have been advised to contact the NSW National Parks and Wildlife Service, the agency responsible for regulating native wildlife. One of the main drivers of Brush Turkey population density in the Milson Precinct is thought to be habitual feeding by certain local residents.
