Summary of Actions Arising (SOA) Bay Precinct 2023

- **Closed for Council** Council either completed related works/tasks or has taken all reasonable steps within its power to resolve issue (for example when matter is beyond its jurisdiction). If the Precinct Committee feels Council can take further steps, they can request Council reopen action.

Council's A/Bushland Management Co-ordinator has advised that Tunks Park, Cammeray Park and Primrose Park are separated by extensive areas of residential housing. There are no opportunities to create a link between these three parks through Council's bushland reserves. However, it may be possible to designate a linkage by combining various existing footpath routes and installing signposting. This kind of project is beyond the scope of Council's Bushland Management Team.	Open/Ongoing

However, this would require a detailed feasibility assessment as the connecting topography is steep, rocky and very close to other potential constraints including remnant bushland and recorded Aboriginal heritage sites.	
		e) Stairs down to the park on the southern side should be built.	The Precinct Committee is requested to provide further explanation for allocation to the appropriate team for investigation e.g. exact location.	
		f) The Northbridge Stairs should be reinstated, improving pedestrian access to Tunks Park.	Council's A/Bushland Management Co-ordinator has advised that advised that this area belongs to Willoughby City Council.	
		g) Bush Track could be created in the southern arm of Flat Rock Gully connecting Tunks Park to Crows Nest.	Council's A/Bushland Management Co-ordinator has advised that bushland in Tunks Park supports the highest diversity of native species recorded in the North Sydney LGA, including native wildlife that are found nowhere else in the area. One of the reasons for this diversity is the lack of public access points through much of the bushland reserve, particularly on the western side of the Strathallan Bridge. Council's Bushland Management Team strongly advise against any track incursions into the remaining bushland areas of Tunks Park for the

			reasons outlined in the <i>Tunks Park Masterplan</i> - Section 2.7.1 - PEDESTRIAN ACCESS. Walking tracks through the Bushland areas of Tunks Park are naturally limited due to the difficult terrain, as well as the need to protect existing habitats from the impacts of track systems. This safeguard would extend to the concept of the circuit track should it affect remnant bushland and or the buffer plantings that protect them.	
		h) There is a desire line between St Leonards Park and Jeaffreson Jackson Reserve.	The Precinct Committee is requested to provide further information on this request/comment.	
		i) West St Nth Sydney provides an easily accessible and beautiful route to Flat Rock Gully and Tunks Park.	Council's A/Bushland Management Co-ordinator has advised that the existing suburban footpaths provide adequate linkages from West St to Tunks Park and Flat Rock Gully.	
		Tunks Park is Crown Land and must be accessible to the public. Are we getting back the 2.7 hectares of construction zone land at Cammeray Park?	Council's Public Projects Interface Manager has advised that the Crown Land that forms the road project construction site (west of the new pathway In Cammeray Park) has been resumed under the <i>Roads Act</i> by Transport for NSW. This has been carried out in conjunction with Crown Lands NSW. Most of this construction site has been removed from Council care and control permanently. TfNSW have repeatedly stated that the area to the north

3	Further Enhancements of Tunks Park - Tunks Park is the beating heart of our Precinct. AC presented concepts for further enhancements, many of which are within the Tunks Park Master Plan (2018). The visuals AC used at the meeting were incorporated into Bay's submission to the Foreshore Parks & Reserves Plan. This was submitted to NSC following this meeting. It is also attached. • The existing walkway on the southern side is a cul-de-sac. Recommend this be extended along the northern perimeter creating a walking circuit. • More seating and low shade trees, like the plantings on the foreshore in Mortlock Reserve, should be added on the southern side. • Circuit pathway could be beautified with selected plantings and inlets for picnic tables. Native plants would provide shelter for small animals, reptiles, insects, and birds. • Storm water is discharged onto the northern side of the park, making the northern track unusable after rain. Recommend increasing pit capacity and connecting the storm water outlets into the culvert. • For similar reasons, increase pit capacity at the Flat Rock Gully end. • New seating could be in the form of attractive sandstone bollards. 		 It is critically important that Plateau residents have a voice continuing through the tunnel construction phase. At Bay's AGM in Nov, a motion was passed to take the next steps to merge Plateau and Bay Precincts. Council has now advised Bay of the process to follow for this to occur. This process will take several months to implement. The first step is to convene a meeting of Plateau residents. This meeting to be chaired by the Mayor of NSC, or her delegate. At this meeting of Plateau residents, it may be preferable for Plateau to decide themselves to reactive as a Precinct in their own right - another viable option for the future. JB expressed his view that the interests of the community would be best served if Plateau Precinct was reactivated, working together with Bay and other Precincts on common concerns. The meeting agreed to keep both options open. 	determine community sentiment. 	GB2A	Parking and speeding - Advocating parking restrictions and reduced driving speed. Bay residents are concerned about the safety of pedestrians walking from Miller St to Tunks Park via The Boulevarde, Rowlison Pde and Brothers Ave. There is no continuous pedestrian access. This forces walkers to cross busy, narrow streets, where vehicles towing boats often move along the access streets at speed. As well, the footpaths are uneven. Speed limits along the access streets are needed urgently. Related email received post receipt of the minutes. (ECM 9328762)	Council's Traffic & Transport Engineer has advised that the natural steep environment with the road cut into the grade of the hill and driveways, creates uneven footpaths. There have not been any crashes in the previous five years. Council is unlikely to be able to achieve a compliant footpath at these locations. Council will investigate improvements such as wider footpaths at these locations, however they would be conditional on constructability and prioritised in accordance with safety data including crash history. 	GB2B	Residents of The Boulevarde, between Nos. 22 to 28 - are also concerned about their safety when exiting these properties in their motor vehicles. There is no visibility when exiting these driveways. As well as reduced speed, please consider parking restrictions by declaring a "no parking" zone opposite Nos. 22 to 28.
