Please complete the application form (available at <a href="https://www.northsydney.nsw.gov.au">www.northsydney.nsw.gov.au</a>, or at Council's Customer Service Centre) and include all required supporting documentation.
- b) Should you wish to appoint North Sydney Council as the Principal Certifier, you must first obtain a Construction Certificate (either from Council or a Private Certifier) and then complete a Principal Certifier appointment application form (available at <a href="www.northsydney.nsw.gov.au">www.northsydney.nsw.gov.au</a>, or at Council's Customer Service Centre) and pay the inspections fee quoted. **Please include a copy of this quote with the application.** Council will review the application, and where all information is correct it will formally acknowledge in writing its acceptance as the Principal Certifier for the job. It is only after this formal written acknowledgement is issued that Council is the Principal Certifier. Once Council formally accepts the Principal Certifier role it will further advise of your requirements as Applicant.
- c) Once all mandatory inspections are completed, an Occupation Certificate must be obtained to occupy or use the approved development. The appointed Principal Certifier can only issue an Occupation Certificate. A separate application for an Occupation Certificate must be made on the Occupation Certificate application form (available at <a href="www.northsydney.nsw.gov.au">www.northsydney.nsw.gov.au</a>, or at Council's Customer Service Centre).
