2. Confirmation of Minutes (on NSC website) and matters arising

Moved PZ, seconded SM. Passed unanimously. Chair reported response from NSC re Grosvenor Lane.

3. Presentation from, Council Bushcare Officer.

Bushcare Program began in 1993.

Aims to manage biodiversity assets and involve the community. 101 volunteers work in 12 areas together with a nursery group at the Coal Loader.

Based in survey in 2010, NSC has 49 hectares of bushland (0.5% of NSC area), comprising 16 Reserves, 2 vegetation communities, 374 native plant species, 200 native wildlife species, Angophora and Blackbutt.

Wallabies and Lyre bird have been sighted in Tunks' Park.

Community Nursery

Propagates 12,000 local native plants used in Bushland Rehabilitation and Environmental Programs and given to residents.

Bushcare Newsletter is available on request.

<u>Annual activities</u> include "Building Bridges to Boorowa" in cooperation with Landcare.

Adopt a Plot aims to rehabilitate degraded Bushland adjoining private property.

<u>Native Havens</u> provides food, shelter and nesting materials. Plants and advice are given to residents.

Wildlife Watch is part of a Citizen Science Program

Threatened Species in NS include Powerful Owl, Large Bent-wing Bat, Microbats, South Myotis (a fishing bat), Grey-headed Flying Fox. Sunshine Wattle (Acacia Terminalis).
