## RE: Façade DA145/23 (201 Miller Street, North Sydney) - Amended Plans

On behalf of the Applicant, The Trust Company (Australia) Limited as trustee for 201 Miller Sub Trust, please find enclosed amended documentation for further assessment of DA145/23.

Amendments have been prepared in response to the North Sydney Local Planning Panel (NSLPP) comments raised at the meeting held 06/12/23 (Item 5 of the Meeting Minutes dated 14/12/23).

The Panel's comments have been reviewed by the project design team to address the issues raised. Two additional supporting documents are included. These provide commentary on the design approach and justification of how the concerns, raised by the Panel, have been addressed.

c. <del>No existing window units on the North</del> Elevation to be deleted to reveal the exoskeleton:	No further action required.
d. Consideration of the removal of the portico to the main forecourt and reinstatement of the original supporting column profiles evident in photographs of 1972 from Stanton Heritage Centre, Local History Collection (n.d.).	Refer to Section 3 of the Local Planning Panel: Response report. Whilst removal of the portico and reinstatement of the original column profiles would result in a positive heritage outcome, any additional works to the ground plane and landscaping not included in this DA will be further considered in a separate Development Application as the facade upgrade is part of a broader plan for the site.

We trust that the information provided will be sufficient for the proposal to be reassessed. The project team welcome the opportunity to present the amended scheme to the Council Officers, and/or to the Panel, at the next available date.
