### **1. Standard Terms**

By entering the North Sydney Christmas Drawing Competition, you agree to the following terms and conditions.

### **2. Entry**

Entry is open to all students from Kindergarten to Year 6 who either live in or attend school within the North Sydney Local Government Area (LGA).

Students living outside the LGA but attending schools within it are also eligible.

The competition has one category. The overall winner's artwork will be featured on street banners displayed across the North Sydney LGA. Vouchers will be awarded to two runners-up.

While schools are the primary entry point, individual submissions are also welcome.

The competition is open to NSW residents only.

North Sydney Council staff and their families are not eligible to enter.

### **3. How to Enter**

3.1 The competition closes at 2pm on Monday 20 October 2025.

Create your artwork in the space provided on the official entry form.

Winning artwork will be professionally printed and displayed on banners throughout North Sydney for the Christmas period 2025. Banners featuring the winning artwork may also be displayed in subsequent years and used for promotional purposes in the future.

There is one overall category for this competition. Prizes will be awarded as follows:

**First Place:** The winner's entry will be featured on the official banner artwork and will receive a \$100 voucher.

**Second Place:** The runner-up will receive a \$50 voucher.

**Third Place:** The third place entry will receive a \$25 voucher.

All prizes will be awarded as digital vouchers, which will be delivered to winners via email.

Prizes are not transferable or exchangeable for cash. The judges' decision is final and no correspondence will be entered into.

No cash prizes will be awarded. Winners will receive recognition and have their artwork featured publicly.

No cash alternative to the prizes will be offered. The prizes are not transferable.

Council reserves the right to alter or cancel the prize offering.
