

## **Terms and Conditions – Stanton Library Community Survey Prize Draw (May 2026)**

### **1. Promoter**

The promoter is North Sydney Council (ABN 32 353 260 317) of 200 Miller Street, North Sydney NSW 2060.

### **2. Promotion Period**

The promotion commences at 12.01am (AEST) on Friday 1 May 2026 and closes at 11.59pm (AEST) on Sunday 31 May 2026.

### **3. Eligibility**

- Entry is open to individuals who complete the Stanton Library Community Survey during the Promotion Period and elect to enter the prize draw by submitting their contact details.
- Employees and Councillors of North Sydney Council are ineligible to enter.
- Entrants under the age of 15 must have the consent of a parent or legal guardian.

### **4. Entry Requirements**

- Entry is limited to one (1) entry per person.
- To enter, participants must complete the survey and provide valid contact details.
- Incomplete, indecipherable or duplicate entries may be deemed invalid at the discretion of the Promoter.

### **5. Prize**

- There is one (1) prize to be awarded.

- The prize is not transferable or exchangeable and cannot be taken as cash.
- The gift card is subject to the issuer's terms and conditions, including expiry.

- The winner will be selected at random from all eligible entries.

### **7. Notification of Winner**

- If the winner cannot be contacted or does not claim the prize within 28 days of notification, the Promoter reserves the right to conduct a redraw.

- If required, a redraw will take place at the same location as the original draw.
- The redraw winner will be notified using the same method as the original winner.

- Personal information collected will be used for the purpose of administering the promotion and contacting the winner.

- Information will be handled in accordance with North Sydney Council's Privacy Management Plan and relevant legislation.
- Entrants may access or update their personal information by contacting the Promoter.
