The following relevant DAs are under assessment or determined:

• DA 293/21 Installation of illuminated advertising 1 Denison St closes 5 Nov

Lights on the west of several city buildings are negative for residents eg, of Edward and Priory Streets. They can affect the wellbeing and health of residents. Precinct considers that the increase in building lights is a major issue and recommends that NSC assesses the steps that may be considered to limit building night lighting.

DA 313/21 Alterations and additions to dwelling. 48 Edward St closes 12 Nov

Precinct considers that the current third storey extension on the west of the house is already too tall and poorly designed and constructed in comparison to the architectural heritage of the area. The proposed two storey extension at the western end of the existing house will bring it close to the boundary fence, overlooking the back gardens of houses at 9, 11 and 13 Priory Rd. Edward precinct will object to the proposed development. Unanimous

Precinct supports the plan and the additional recommendations made by John Berry of Bay Precinct. His recommendations related to the limitation of flood lighting of parks and reserves; noise pollution and synthetic turf which make wildlife residence in the areas problematic and should be avoided as far as possible.

4. Impact of **brush turkeys** in the precinct.

Brush turkeys have increased greatly in number in Edward Precinct (and much of North Sydney) over the past five years, largely due to the eradication of foxes by NSC. Turkeys are already problematic, as shown by a small-scale survey undertaken by our precinct secretary in Lord, Short and Bank streets. Of the 22 residents interviewed on 6 and 7 November, 50% considered turkeys to be a major problem, 27% a minor problem and 23% no problem.

The following motion was passed unanimously:

"Precinct requests NSC to discuss with the Department of Planning, Industry and Environment and National Parks and Wildlife how to improve the management of brush turkeys in North Sydney."

Precinct residents with ideas are welcome to contact precinct.

5. Berrys Bay issues

DA 57/19 Floating Dry Dock, the Section 34 conciliation conference was terminated at the Land & Environment Court as no agreement was reached. Hearing is set for May 2022, which will include on site visit.

Woodleys: precinct looks forward to Council gaining care and control over the site.

6. **Combined Precinct Committee** - meeting 19 October

WHTBL – the main focus was on the Cammeray area, relating to the Warringah Freeway works and land use. There was no discussion of the problems likely to arise in North Sydney if the Western Harbour Tunnel and Beaches Link are constructed.

As reported in our July meeting minutes, Edward Precinct opposes the construction of both tunnels, at least until alternative transport options have been fully assessed.


JC has been in contact with the Upper House Parliamentary Inquiry into the tunnels, and reports that (at least) one parliamentarian on the committee fully supports Edward's position. Publication of the Inquiry report is unlikely before early to mid-2022.

7. NSC Meeting Minutes files


A review of the NSC meeting minutes since August found that:
