3. Additional items added to the Agenda

a) Passing of JR

A minute silence was observed to acknowledge JR who passed away in December 2019. JR had worked for the Neutral Precinct for over a decade and was involved in many community activities including bush care, land care and as an ESL teacher.

b) Councillor Jessica Keen - attendance

GC welcomed Councillor Jessica Keen and invited her to talk to current issues. JK also acknowledged JR as an active member who will be missed. JK and GC are looking to find a way to remember JR.

JK spoke to and answered questions about the following matters

Ward boundaries:

The Electoral Commission advised the Council that, following the vote at the last LGA election to change to a non-elected Mayor, the Council requires 10 councillors with effect from the next LGA election in September 2020. The Mayor will be chosen by the Councillors. The wards are Northern Ward to be named St Leonards and Southern Ward - Cammeragyl. Each ward has approx. 26,000 residents. A recission motion. Discussion generally supported an east/west division citing issues are very different on each side of the Warringah Expressway. E.g. the Metro in the West and Military Road in the East.

North Sydney Pool:

No further updates. It is currently in a DA process. The consultation period has closed with a Council decision scheduled for this year.

Code of Meeting Practice:

Councillor Ian Mutton has submitted a Notice of Motion "that the Council resolve that a Public forum be held prior to and starting one hour before each and every ordinary and extraordinary meeting of Council and of each and every meeting of Committees of the Council"

The meeting unanimously supported the motion. JK indicated she relied on public comment /debate on issues to inform her decisions as a Councillor.

Western Harbour Tunnel:

An EIS is out for consultation. The documentation is massive but CG encouraged Precinct members to take time to read and provide comments.

Streetscape Committee:

JK indicated the next meeting was in April and expects an agenda item on the Neutral Bay town centre project. The agenda will be available on the Council Website.

GC thanked Councillor Keen for attending the Precinct meeting.

An attendee indicated that in peak times additional buses travel between NB Junction and Neutral Bay (Hayes St) Wharf and between Cremorne Junction and Cremorne Point Wharf. Consultation on the Timetable changes is still open and it was suggested attendees provide feedback on this possible issue
