## NEUTRAL PRECINCT MINUTES Tuesday 14 December 2021, commenced at 7:00 pm

- 1. Attendees were reminded of the current procedures for holding precinct meetings in the COVID 19 Pandemic Period.
- 2. Apologies: LS
- 3. Additional items added to the Agenda.
  - i. Additional DAs 414/2021 32 Shellcove Road Kurraba Point and 420/2021 82 Shellcove Road Kurraba Point. See item 6.
- 4. Business from minutes of meeting held on 9 November 2021:
  - i. Following review, the minutes were moved by DM and seconded by TM as correct.
- 5. Ramp designs and Alfred Street cycle path.

## Discussion:

- Acknowledged that the proposal is divisive in the community. Cyclists that use the Bridge are in favour of a ramp but the residents of Milsons Point and adjacent communities are concerned about the designs, the integration of a ramp into the area adjacent to the iconic Harbour Bridge, and the impact on the Kirribilli Markets both during and post the construction phase.
- TfNSW should be building a cycleway connection between Cammeray and the Bridge. There is a window of opportunity to do this as part of the Warringah Freeway Upgrade and would deliver a seamless approach to the bridge for cyclists rather than navigating through the narrow streets of North Sydney.
- It was agreed that once again a major infrastructure project in the LGA will be a Sydney wide gain and a significant loss of amenity for the local community, without really resolving the disconnect for cyclists travelling into the City and beyond.
