The meeting felt that this was an understatement as traffic started to react to the closure and find that the best route was through Grosvenor Lane. The 10km/h speed limit does not seem to be followed and pedestrians are not given right of way. Closure of Young St access to and from Military Rd also increases traffic volumes at intersections at Ben Boyd, Waters and Winnie St. At these three intersections motorists have to share time with pedestrians and it is increasingly difficult to turn onto Military Rd.
