Summary of Actions Arising (SOA) 2020 - Waverton Precinct

- **Closed for Council** Council either completed related works/tasks or has taken all reasonable steps within its power to resolve issue (for example when matter is beyond its jurisdiction). If the Precinct Committee feels Council can take further steps, they can request council reopen action.

	3.2	Quarantine Launch Depot Compliment - Precinct congratulates Council for their persistence which led to acquiring the buildings. However, there was disappointment expressed at the State requiring a money transfer for a site which is not sewered and is contaminated. The disappointment included that the full site was not transferred, given that its heritage integrity requires the wharf and associated shoreline buildings (coal store etc) to be integrated with the cottages which were homes for the skippers of the vessels (Pasteur and Jenner) moored at the wharf. Council is urged to press the logic of this with the State with a view to TfNSW releasing their holding so that the site can be amalgamated and properly presented as a unified heritage site.
