The recycling dockets provided by URM confirm all the recyclable materials in the commingled yellow bin are being processed and re-used. This is supported by information received from recycling processor Visy. All paper/cardboard is processed at Visy's mills. Plastics are sent to Visy's plastic plant and turned into resin pellets.
