Copy of a letter from a concerned resident in Shirley Road that now has no available unlimited parking, sent to the Director Engineering and Property Services was subsequently received. June		Council 's "New" Draft Code of Meeting Practice - is open for public feedback. This new draft code is modelled on the Code issued by the Office of Local Government but includes many of the optional provisions which if included in the final adopted code will severely limit the rights of the public to make comment, limit the number of issues that anyone can speak on, restrict the number of people who can speak on a particular issue and even worse, deal with public comments in a separate forum not on the same day as the Council meeting. In other words, Council will meet after having listened to comments and decided in closed session how they should vote on a particular issue. The public is urged to strongly object to this new code by lodging a submission by the closing date of 20 June. The matter will then most likely be on the agenda of the Council meeting in July. 		Council's application for a Special Rate Variation - which was partly approved by IPART provides for 3 consecutive years of 7% increase/year (including the Rate Peg) in the rate for dwellings, commencing from 1 July 2019. Many residents opposed this application and lodged objections with IPART accordingly. IPART received 77 submissions (an unprecedented number) many of which were objections. Although the SRV has been approved there is no need for Council to implement it given the strong financial position of Council. 		Council Actions - noise from personal trainers and enthusiasts was raised by one local resident who is disappointed that Council is unable or unwilling to enforce the Code of Conduct for use of public parks by personal trainers. They arrive at Berry Reserve at 5:30 am and commence training activities by 6:00 am and generate huge disturbance. This should not be allowed when Council prohibits use of lawnmowers and commencement of building works before 7:00 am. Cr Baker will follow up.	Council's Manager Ranger and Parking Operations has advised that this is not a matter for Rangers as the Code of Conduct is voluntary and voices/talking at 6:00am is considered acceptable. Council's Manager Parks and Reserves refers the Precinct Committee to advice provided in the April 2019 Summary of Actions, which is unchanged.	Closed for Council
