Pursuant to Section 4.55 of the Act notice is hereby given of the determination by the consent authority of your request for a modification to Development Consent No. **400/17** and registered in Council's records as Application No. **400/17/5** relating to the land described as **63 Ernest Street, Crows Nest**.

Your request for the modification of the Development Consent as set out in Notice of Determination dated **16 August 2018**, has been determined in the following manner:

***Condition A1 shall be amended to read as follows:***

(Reason: To ensure that the form of the development undertaken is in accordance with the determination of Council, Public Information)

**Condition C16 shall be amended to read as follows:**

**BASIX Certificate**

C16. Under clause 97A(3) of the *Environmental Planning and Assessment Regulation 2000*, it is a condition of this development consent that all the commitments listed in BASIX Certificate Nos. **A315378\_03 (No. 63) and A315425\_03 (No. 63A)** for the development are fulfilled. Plans and specifications complying with this condition must be submitted to the Certifying Authority for approval prior to the issue of any Construction Certificate. The Certifying Authority must ensure that the building plans and specifications submitted, referenced on and accompanying the issued Construction Certificate, fully satisfy the requirements of this condition.

(Reason: To ensure the proposed development will meet the Government's requirements for sustainability and statutory requirements)

*The following conditions being added following condition C16:*

**Reduction of living room extensions**

C17. The proposed 1.5m extension of the living room of each dwelling shall be reduced to 1.0m.

(Reason: Consistency with desired character and reduce aggregate impact of site coverage variation)

**Extension's Roof Design**

C18. The roof over the approved 1.5m extension of the living room being mended to a skillion design.

(Reason: The approved development will be more compatible with other development in the Heritage Conservation Area)

**Replace Door Type**

C19. The bifold door on the ground floor of the dwelling adjacent to No 69 Ernest Street, east of the site, as shown plan 101 Issue A dated 30/06/2022, shall be replaced with a sliding door.

(Reason: To help preserve the neighbour's amenity)

---

	The development application has been assessed and found to be satisfactory, having had regard to applicable legislation, plans and policies.
<b>Reasons for Approval:</b>	Accordingly, the subject applications to modify the consents are recommended for approval, subject to conditions, to be either modified or added to the consents, as detailed below.  As the number of submissions was 7, the recommendation must be co-signed by the Manager, Development Services.
<b>How community views were taken into account:</b>	Matters raised by submissions made when the applications were notified in accordance with Council's Community Engagement Protocol have been considered, as required.

The conditions attached to the original consent for Development Application No. **400/17** by endorsed date of **16 August 2018** still apply.

**ADVISINGS**

- (a) Council is always prepared to discuss its decisions and, in this regard, please do not hesitate to contact **Jim Davies**. However, if you wish to pursue your rights of appeal in the Land and Environmental Court pursuant to Section 8.7 of the *Environmental Planning and Assessment Act 1979* (as amended), you are advised that Council generally seeks resolution of such appeals through a Section 34 Conference, instead of a full Court hearing, subject to any further advice to the contrary from Council's Solicitors and senior staff. Such an approach is less adversarial, it achieves a quicker decision than would be the case through a Court hearing and it can give rise to considerable cost and time savings for all parties involved.

- (b) Pursuant to Section 8.2, an applicant is able to request Council to review its determination. An application for a review under Section 8.2 of the Act must be made no later than 28 days after the date on which the application for the modification of the development consent was determined.
- (c) Prior to commencing any building, subdivision or associated constructions works, the following provisions of *the Environmental Planning and Assessment Act 1979* (the 'Act') are to be complied with:
- (i) A Construction Certificate is to be obtained in accordance with Section 6.3 of the Act.
  - (ii) A Principal Certifier is to be appointed and Council is to be notified of the appointment in accordance with Section 6.6 of the Act.
  - (iii) Council is to be notified at least two (2) days of the intention to commence building works, in accordance with Section 6.6(2)(a) of the Act.
- (d) You are advised that changes to the external configuration of the building, changes to the site layout, density and unit configuration internal changes to the proposed building or any changes to the proposed operation of a use **MAY** require the submission of a further modification under Section 4.55 of *the Environmental Planning and Assessment Act, 1979* (as amended).

Council staff would be pleased to assist in identifying such changes which may require the submission of a modification of a Development Application under Section 4.55 of *the Environmental Planning and Assessment Act*.
