### **PURPOSE:**

The purpose of this report is to determine a schedule of Council Meeting dates for 2024.

### **EXECUTIVE SUMMARY:**

- The Local Government Act prescribes that councils are required to meet at least 10 times each year, each time in a different month.
- In June 2022, Council adopted a fortnightly schedule for Council meetings.
- This report proposes a schedule of Council meetings for 2024.
- Dates for the 2024 meetings of the Reference Groups and Streetscape Committees will be the subject to a further report in November 2023.

### **RECOMMENDATION:**

**1. THAT** Council adopts the attached Council Meeting schedule for 2024.

**2. THAT** Council notes the attached planned Agenda publication dates for Council Meetings in 2024.

**3. THAT** a further report be submitted to Council in November 2023 regarding a schedule of 2024 meeting dates for the Reference Groups and Streetscape Committees.

## Background

At its meeting held 27 June 2022, Council resolved as follows (in part):

2.THAT Council adopts the attached Council Meeting schedule for 2022 and 2023, and that a further report be provided to Council in September 2023 for the purpose of determining Council Meeting dates for 2024. 3.THAT Council notes the attached planned Agenda publication dates for Council

### Report

Meetings in 2022 and 2023.

In accordance with the frequency of Council Meetings adopted in 2022, attached is a proposed meeting schedule for 2024 that provides for Council Meetings twice a month with the following exceptions:

- No Council meeting proposed in January this is proposed due to January being an opportunity for staff to take leave, which assists with the management of leave balances.
  The first Ordinary Meeting would be held on Monday 12 February.
- Monday 10 June no Council Meeting proposed due to the King's Birthday and possible dates for ALGA Conference, resulting in only one Council Meeting in June.
- Monday 8 July no Council Meeting proposed to allow staff time to manage end of financial year processes and implement adopted integrated plans and associated changes from the June 2024 Council meeting.

The Local Government elections are scheduled to be held on Saturday 14 September 2024.

As the caretaker period prior to elections is expected to commence on or about 16 August 2024, the 26 August and 9 September Council meetings will be subject to the caretaker provisions.

While an Extraordinary Meeting will be held once the outcome of the election is known, this can be scheduled at that time. No meeting dates after the elections have been scheduled, to allow the newly-elected Council to determine its own meeting cycle.

The Code of Meeting Practice provides that a Councillor may give notice of any business they wish to be considered by the Council at an Ordinary Meeting by way of a Notice of Motion. A Notice of Motion must be in writing and must be submitted three (3) business days before the agenda and business papers are distributed.

The due dates for Notice of Motion and the agenda distribution dates are included in the attached schedule.

Council also has a network of Reference Groups and Streetscape Committees. It is proposed that a further report regarding meeting dates for 2024 be submitted to Council in November 2023.

### **Consultation requirements**

Community engagement is not required.

### **Financial/Resource Implications**

Related financial implications include staff costs. The spread of 'ordinary hours' under the Local Government (State) Award 2020 are from 6am to 6pm. Hours worked outside this spread of hours are payable at the overtime rate. The overtime rate of pay is time-and-a-half for the first two hours and double time after that. Employees may elect to take Time In Lieu instead.

This clause does not apply to Senior Staff (as defined in the *Local Government Act 1993*) nor to those employees engaged under the Award in the Executive Classifications (Band 4) where the following applies:

Employees engaged in Executive Band 4 may be required in addition to their ordinary hours, to attend meetings of Council and standing and/or special committee meetings. For the purpose of this subclause an employee who is required to attend these meetings may be entitled to claim overtime for actual hours worked after 11pm.

### Legislation

Section 365 of the Local Government Act prescribes that the council is required to meet at least 10 times each year, each time in a different month.
