Background

Report

At its meeting on 27 October 2025, Council resolved:

- 1. THAT Council undertake community consultation on the proposed Special Variation options contained within this report from 29 October to 3 December 2025.
- 2. THAT Council place the Draft Long-Term Financial Plan on public exhibition from 29 October to 3 December 2025.

Following the community consultation process, it is proposed to schedule an Extraordinary Meeting of Council at 7.00pm on Monday 19 January 2026 to consider a report regarding a proposed special rate variation as a medium-term pathway towards restoring financial sustainability and service resilience.

To ensure all registered speakers are accommodated and to avoid the crowded conditions in the Council Chambers, it is recommended for the following conditions to apply to the meeting:

- the Public Forum will commence at 6 pm;
- the Extraordinary Council Meeting will commence at 7.00 pm, upon conclusion of the Public Forum;
