#### **EXECUTIVE SUMMARY:**

Members of the Shorelink Library Network convened on 22 June 2016 and due to a lack of quorum resolved to present the outcomes by way of a report. Council's attention is drawn to:

**Item 7 Manly Council amalgamation**: the Northern Beaches Council representative advised: Manly has committed to remain with the Shorelink Network until September 2017 and will continue to advocate the benefits of the Network. During the coming months our long term participation in Shorelink will be reviewed by the Executive of Northern Beaches Council and the Shorelink Committee will be advised of our future direction according to the terms of the Deed of Agreement.

## **Item 10:** General Business

Discussion: With regard to uncertainty over who might be an appropriate Councillor representative throughout 2016/17 for the Northern Beaches it was resolved: *THAT Legal advice be sought by the Agent Council* [North Sydney] *clarifying the impact on the Deed of Agreement of the current and proposed amalgamations*

## **DETAIL**

# **St Thomas Rest Park**

It has been more than 40 years since St Thomas Cemetery was re-landscaped as the presentday St Thomas Rest Park, and 30 years this year since the Sexton's Cottage was opened as a museum. Nonetheless conservation work is ongoing. Most recently the Tiffin family headstone has been conserved and re-erected in its original location. The stone was badly damaged some time during re-landscaping or afterwards. Two pieces of the headstone were 'discovered' half covered by leaf material by historian Ian Rannard in the course of his research and brought to the attention of the Council Historian. The Tiffins were linked by marriage to the Blue family. Mary Blue, daughter of Billy Blue, married Robert Tiffin in 1830. They had two sons who did not survived childhood. Robert died in 1854 and Mary remarried. When she died in 1894, however, Mary was buried with her first husband and two sons. Further research revealed that the Tiffin's plot at St Thomas Cemetery was adjacent to the Blue family plot. For this reason, and out of respect for the families, it was decided to return the headstone to its original location. As only two pieces of the sandstone monument survived it was also decided to join them with stainless steel rather than patch extensively with concrete fill. The effect shows clearly the effect of time. A plaque will be placed near the headstone reiterating the entire inscription and explaining the decision to return it to the original location. The re-instating of the headstone does not impede passive recreation in the park and accords with the 2015 Conservation Management Plan.



Nan was a long serving School Librarian at North Sydney Boys High and a lifelong champion of literacy and local history; giving 30 years of service to North Sydney Council's Library and Historical Services Committees.

The judges of the award are all professional writers: multiple award winning children's author Ursula Dubosarsky, young adult author Will Kostakis, poet Tim Sinclair; North Sydney Council's Writer in Residence, Yvette Poshoglian; and local author and Library Champion, Ceridwen Dovey.

11yrs: Ciara Flex for 'World's Hardest Land'

**12yrs:** Jessica McCann for 'The Great Escape Plan'

13 yrs: Cooper Rands for 'The First Chair'\*

**14-15 yrs:** Lucinda Peace for 'The War of Flame and Trees'

**16-18 yrs**: Sophie Goodin for '*Dinner Table*'

The Awards were presented by Mayor Jilly Gibson at a ceremony in the Library on 8 June, 2016. Winners of the 5 age categories did a marvellous job of reading their stories out on the night. Afterwards families and teachers stayed to enjoy some light refreshments and read all of the winning works on display.

Prizes worth over \$2,000 were presented to the writers. The sponsors this year were: The Ensemble Theatre, The Powerhouse Museum, Local resident Joan Dunnwald, Local artist;



and Council. An additional prize was offered to all winners and place-getters of a chance to attend a Writers' Masterclass with Judge Will Kostakis in the following school holidays.


It was a little bit of sneaky work for the librarians after the library had closed, but was worth it for the level of delight and engagement with the young library patrons.

# ITEM 4: Matters arising from the Minutes of 27 April 2016

# ITEM 5: Shorelink Network Report 30/01/16 – 15/04/16

Additional ADSL2+ services from TPG have been ordered for the 2016/17 financial year for Lane Cove, Mosman, Stanton and Chatswood libraries. Mosman and Chatswood will be installing one additional line each, whilst Lane Cove and Stanton will be installing two additional lines.

Switches in the libraries were ordered and upgraded in May and are now operational.

Shorelink office is investigating alternatives to the current McAfee anti-virus software which expires on June 30 2016. One viable option Shorelink is considering is Webroot, which is supplied by a UK based company, and is cloud based. This means that no hardware is required, antivirus scanning and protection is done in real time and not dependent on periodic virus signature file updates.

There was no report of network wide system downtime during this period, though a significant slowdown in the speed of the Aurora LMS was noticed in late May and early June. The slow-down is also sporadic. Initial investigations indicate that the MPLS lines are connected and operating with normal speeds, however, the slowdown occurs when complex searches are being done on the Aurora software. Investigations are still ongoing at this stage.

- 3. Hardware maintenance shows a new estimate of \$168,906 reflecting member Councils contribution of funds to the purchase of switches and firewalls.

# ITEM 7: <u>Manly Council amalgamation</u>

On 12 May 2016 the Minister for Local Government, Paul Toole, announced the newly formed Northern Beaches Council an amalgamation of Manly, Pittwater and Warringah councils. At this time Mark Ferguson was appointed interim General Manager and Dick Persson was appointed the Administrator.

As a result of the amalgamation process Manly will have no Councillor representative on the Shorelink Committee until the next council elections scheduled in September 2017.

Manly has committed to remain with the Shorelink network until September 2017 and will continue to advocate the benefits of the network. During the coming months our long term participation in Shorelink will be reviewed by the Executive of Northern Beaches Council and Shorelink Committee will be advised of our future direction according to the terms of the Deed of Agreement.

# ITEM 8: Report on Lane Cove Library's automated handling system

In March 2016 Lane Cove Library installed an automated handling system which includes return chutes, buffer, singulator, sorter and returns bin. The Library used a Local Government Procurement Contract and selected FE Technologies to provide the solution. It is the first installation of this type of system in Australia.

# ITEM 9: Second report on City of Sydney

In January 2015 Shorelink representatives met with senior staff at City of Sydney to encourage them to consider the cost benefits of joining Shorelink. Shorelink's Strategic Objective Number five has as its specific actions:

- 1. Distribute information about the benefits of the consortia model to other councils.
- 2. Send follow-up correspondence and seek meetings to discuss the possibility of co-operation.

# THE purpose of the meeting was described as:

- (A) Allow for an understanding: Explain how Shorelink works from various points of view: staff, public, councillors etc.
- (B) Allow for readiness: Raise in our colleague's mind the benefits of Shorelink so that if a suitable moment in the evolution of their own service arrives where their users would benefit from joining Shorelink, that the moment is not missed.

Key relevant facts and documents were presented using data that was available at the time, for 2013/14. No response was received from City of Sydney at the time and the merger proposals discussion commenced shortly thereafter. The City of Sydney's merger proposal has now concluded.

Discussion: It was agreed at this point that Shorelink's priority needed to be promoting its services to the Northern Beaches Council. It was further agreed that there would be benefits in additional research about where residents from member councils work and therefore which libraries joining Shorelink would provide the most benefit.
