Consent for the Metro City & South-West (Metro) project was granted by the Department of Planning and Environment on 9 January 2017. The consent can be viewed in full at www.majorprojects.planning.nsw.gov.au

The project will deliver new railway infrastructure for Sydney, including two new Metro stations within the North Sydney Local Government Area - at Crows Nest and Victoria Cross (North Sydney Centre). Construction of the line is scheduled to begin in 2017, with train operations underway by 2024.

In accordance with the various conditions of consent, a Traffic and Transport Liaison Group (TTLG) has been established to inform traffic and transport measures during construction and operation of the project. The TTLG is chaired by the Sydney Coordination Office (SCO) and comprises representatives from the relevant Road Authorities, which includes North Sydney Council. The TTLG meets monthly and a smaller group of representatives known as the Traffic Control Group (TCG) meets weekly to discuss impending construction-related traffic management matters.

The Construction Traffic Management Plans (CTMPs) must be developed in consultation with the TTLG. The RMS is the approval authority for the CTMPs, following endorsement by the SCO.

The purpose of this report is to update the North Sydney Traffic Committee on the current status of the project and upcoming works affecting local roads.

Four short-term parking spaces were installed to satisfy a condition of a Development Application at 101-111 Willoughby Road to benefit the child care centre during drop off and pick up times. This matter was considered at the 508th Traffic Committee meeting dated 24th March 2017 with the recommendation that: "the recommendation concerning parking restrictions in Atchison Street, Crows Nest be adopted and the Rangers enforce parking restrictions and report back to the next Traffic Committee meeting on 16 June 2017. (4.2(1))".	A site investigation in Atchison Street between Alexander Street and Willoughby Road revealed that there are a total of 2 unrestricted, 28 x 1 Hour Parking spaces, permit holders excepted, and four (4) x 15-minute parking spaces, 8am-9:45am, 2:30pm-6pm Mon-Fri (unrestricted other times). There are 2 car share parking spaces in Atchison Street and there are five (5) unrestricted parking spaces in Willoughby Lane south of Atchison Street. Approximately 82% of the 1P restricted parking spaces, 100% of unrestricted parking spaces, 100% of 15 minutes parking spaces (being unrestricted at the time of visit) and 50% of the car share spaces in Atchison Street were occupied during the parking occupancy survey. All of the unrestricted parking spaces in Willoughby Lane were also occupied. In total, Atchison Street has an average occupancy of 85%. The unrestricted parking spaces generally have a higher occupancy rate than the restricted parking spaces. Generally parking meters result in a better compliance with the parking restrictions which means that the time limit can be increased to allow the parking to be used in the most efficient way whilst still ensuring that residents and visitors can actually find a parking space when they arrive. To alleviate the parking issue and improve parking turnover in the area, it is recommended that Parking Meters be introduced in Atchison Street from Oxley Street to Alexander Street.
