Pursuant to Section 4.55 of the Act notice is hereby given of the determination by the consent authority of your request for a modification to Development Consent No. 256/17 and registered in Council's records as Application No. 256/17/2 relating to the land described as 50 Ridge Street, North Sydney.

Your request for the modification of the Development Consent as set out in Notice of Determination dated 5 July 2018, has been determined in the following manner: -

1. To Modify Condition A1 of the consent so as to read as follows:

Development in Accordance with Plans/documentation

A1. The development must be carried out in accordance with the following drawings and documentation and endorsed with Council's approval stamp, except where amended by the following conditions of this consent.

2. Condition A4 of the consent is amended to read as follows:

Compliance with Lighting Report

A4. The proposed development approved by this consent shall be carried out in strict compliance with all recommendations stated within the Lighting Report(s) prepared by Lighting, Art & Science and dated 15 April 2019. The orientation of the luminaires shall be in accordance with the requirements of the lighting report.

The lighting shall comply with the following requirements:

Australian Standard AS 4282 'Control of the Obtrusive Effects of Outdoor Lighting'.

(Reason:

To ensure that the lighting is installed in accordance with the design and specifications outlined in the lighting consultant's report)

The Application seeks modification approval to Development Consent No. 256/17 for installation of five (5) new light poles at North Sydney Bowling Club. The proposed replacement lighting is associated with the use of the site by North Sydney Bowling Club and The Greens, a food & drink premises associated with the club use.

Reason for approval:

The proposed Modifications include the erection of two additional lighting poles around the Club bowling greens following removal of two additional wooden lighting poles from the site. No change is proposed to existing approved uses at the site.

The Application has been accompanied by an updated Obtrusive Lighting Report addressing the additional lighting poles indicating minimal additional lighting impacts associated with the amended proposal.

The modifications do not result in any material amenity impact to adjoining properties or the surrounding area. The proposed modifications are consistent with the reasons for the granted of development consent to the originally approved development and is considered to be acceptable.

How community views were taken into account:

The application was notified between 9 August 2019 and 23 August 2019. Adjoining owners and the Stanton Precinct were notified of the proposal. No submissions have been received in response to this notification.

The conditions attached to the original consent for Development Application No. 256/17 by endorsed date of 5 July 2018 still apply.

- (c) Prior to commencing any building, subdivision or associated constructions works, the following provisions of the Environmental Planning and Assessment Act 1979 (the 'Act') are to be complied with:
 - A Construction Certificate is to be obtained in accordance with Section 6.3 of the Act. (i)
 - (ii) A Principal Certifier is to be appointed and Council is to be notified of the appointment in accordance with Section 6.6 of the Act.
 - Council is to be notified at least two (2) days of the intention to commence building (iii) works, in accordance with Section 6.6(2)(a) of the Act.
- (d) You are advised that changes to the external configuration of the building, changes to the site layout, density and unit configuration internal changes to the proposed building or any changes to the proposed operation of a use MAY require the submission of a further modification under Section 4.55 of the Environmental Planning & Assessment Act, 1979 (as amended).
