# 5.2. Ben Boyd Lane conversion to one-way southbound

Report of Lizzie Cheng, Traffic & Transport Engineer

Conversion of Ben Boyd Lane to one-way southbound between Belgrave Street to Grosvenor Street, to improve pedestrian safety and accommodate increasing high density development with driveway positioned in Ben Boyd Lane.

The Conversion of Ben Boyd Lane to one-way was investigated by Council previously, all traffic counts and affected residents have been surveyed with options. With the majority of residents supporting conversion to one-way southbound, on 2 July 2021, Council submitted a Traffic Management Plan (TMP) to Transport for NSW (TfNSW) for the approval of the conversion of Ben Boyd Lane between Belgrave Street to Grosvenor Street to one-way southbound. The TMP is finally approved by TfNSW on 30 March 2022.

Associated signages cost to implement the changes.

Traffic Committee Meeting - 10 June 2022 Minutes

The purpose of this report is to provide an update on current works and impacts associated with the Transport for NSW Western Harbour Tunnel and Warringah Freeway Upgrade project (SSI 8863).

The Western Harbour Tunnel and Warringah Freeway Upgrade project SSI 8863 was approved by the Minister for Planning and Public Spaces on 21 January 2021. The project is being undertaken by Transport for NSW.

Warringah Freeway Upgrade Early Works commenced in April 2021 and impact on a number of Council roads adjacent to and alongside the Warringah Freeway. Transport for NSW has exercised functions of a roads authority under the Roads Act 1993 for those roads.

This report provides a high-level overview of the current work sites and summary of complaints received by Council.

## 6.2. Standing Item - Sydney Metro - Project Update

Report of Iman Mohammadi, Public Projects Engineering Officer

The purpose of this report is to update the North Sydney Traffic Committee on the current status of the Metro City & South-West (Metro) project and upcoming works affecting local roads.

Updates are also provided on the Sydney Metro website at <a href="https://www.sydneymetro.info/">https://www.sydneymetro.info/</a> Consent for the Metro City & South-West (Metro) project was granted by the Department of Planning and Environment on 9 January 2017. The consent can be viewed in full at <a href="https://www.majorprojects.planning.nsw.gov.au">www.majorprojects.planning.nsw.gov.au</a>.

The project will deliver new railway infrastructure for Sydney, including two new Metro stations within the North Sydney Local Government Area - at Crows Nest and Victoria Cross (North Sydney Centre). Construction commenced in early 2017, with train operations

expected to be underway by 2024.

In accordance with the various conditions of consent, a Traffic and Transport Liaison Group (TTLG) has been established to inform traffic and transport measures during construction and operation of the project. The TTLG is chaired by the Sydney Coordination Office (SCO) and comprises representatives from the relevant Road Authorities, which includes North Sydney Council. The TTLG meets monthly and a smaller group of representatives known as the Traffic Control Group (TCG) meets weekly to discuss impending construction-related traffic management matters.

The Construction Traffic Management Plans (CTMPs) must be developed in consultation with the TTLG. TfNSW is the approval authority for the CTMPs, following endorsement by the SCO. There are no direct financial implications arising from this report.

# 3. Brightmore Precinct raised concerns in relation to the permanent "no Right turn" from Winnie Street – there is a "consultation" flyer out now

The Mayor advised the Committee that the community concerns in regards to the "no right hand turn" from Winnie Street into Military Road and the lack of community consultation.

Transport for NSW stated that it is currently sitting at a timed right turn from 6am till 10am and 3pm till 7pm. The reason it is being investigated and that Transport for NSW is intending to undertake this, is because of the number of right turn crashes at Winnie Street the conflict in through movements and to improve efficiency for general traffic. They are looking at making it a full-time right turn ban, excluding buses to proceed on 12 July 2022.

A Motion was moved by the Mayor and seconded by Councillor Santer,
